*the Mandator and the Mandatory No. 1 to 6 may also be jointly referred to as the **Controllers***

on the below stated date, have agreed on the Amendment to the Mandate Contract concluded on August 1st, 2015 as follows:

1. This Amendment is concluded pursuant to the Art. 26 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, repealing Directive No. 95/46/EC (General Data Protection Regulation).
2. The basic legal relationship between the participants of this Amendment is governed by the Mandate Contract of August 1st, 2015 concluded between the Mandator, on the one side, and Mandatories No. 1 to 6 on the other side. In particular, it is pointed out for the purposes of the protection of personal data, the following distribution of tasks between the Mandator, on the one side, and the Mandatories No. 1 to 6 on the other side:
 - a) the visitor registers with the Mandator
 - b) the model is registered with one of the Mandatories
 - c) both, the Mandator and the Mandatories are the points of payment depending on the form of payment
 - d) the Mandatories shall execute payouts to the registered models.
3. In relation to the Mandator, under the persons concerned are understood the registered visitors. In relation to the Mandatories, under the persons concerned are understood the registered models and the registered visitors.
4. The Mandator and the Mandatories No. 1 to 6 are the Controllers in accordance with the General Data Protection Regulation, and since their activities, within the meaning of the Mandate Contract referred to in (2) of this Article of the Amendment, are closely interconnected, the participants of this Amendment are considered to be the joint Controllers.
5. The participants of this Amendment have agreed as follows:
 - a) for the accuracy of the personal data processed is liable each of the Controllers to the extent of their participation in the joint activity
 - b) the one of the Controllers who is obliged to obtain the personal data exclusively for a defined or established purpose, whereby it is inadmissible to obtain the personal data under the pretext of another processing purpose or other activity
 - c) the exchange of personal data between the Controllers takes place electronically (by e-mail)
 - d) only the Mandator is liable for the performance of the obligations towards the persons concerned and the Office for Personal Data Protection

- e) only the Mandator provides the information to the persons concerned pursuant to the Art. 13 and 14 of the General Regulation on the protection of personal data
 - f) the point of contact for the persons concerned shall be the Madator
 - g) all the costs connected with the performance of the obligations under the General Data Protection Regulation shall be borne by the Mandator
 - h) notwithstanding the transfer of responsibilities under the preceding paragraphs to the Mandator, the persons concerned may exercise their rights in respect of and against each of the Controllers
 - i) the Controllers shall undertake to inform each other about safety incidents
 - j) the Controllers undertake to cooperate in fulfilling their obligations under the GDPR, in particular as regards the exercising of the rights of the persons concerned, by the fulfillment of the obligation to provide information to the persons concerned, by the evaluation and reporting of security incidents, as well as the adoption of appropriate measures for the protection of personal data
 - k) the Controllers undertake to inform each other in advance about the intention to entrust another/new processor with the processing of personal data.
6. The joint activity of the Mandator and the Mandataries No. 1 to 6 relates to the following information systems:
- IS Registered models
 - IS Registered visitors
 - IS Daily bonus for registered models
7. The purpose of the processing of personal data in the information systems referred to in (6) of this Amendment is:
- the fulfillment of the law of obligation and commitments in a mutual lawful relation.
8. The persons concerned are the following persons:
- registered model
 - registered visitor
- A. Not addressed matters in this Amendment are governed by the General Data Protection Regulation.
- B. This Amendment is made out in 7 copies, each of the participants obtains one copy.
- C. This Amendment shall enter into force on May 25th, 2018.
- D. The participants declare that they have understood the content of this Amendment, agree with its contents, in witness whereof they freely and seriously set their hands hereunder.
